CAD IT and PROMETEIA have come to a strategic agreement aimed at supplying financial institutions with an integrated solution regarding projects for "Investment Adequacy to the profile of client risk".

An important Italian banking group has already chosen the new "IAC – Modulo VaR" software developed by CAD IT and PROMETEIA.

CAD IT and PROMETEIA have signed a strategic agreement for the creation, development and sale of a software called "IAC Modulo VaR" to provide financial institutions with an integrated solution for projects of "Investment adequacy to the profile of client risk".

The complementarity of the offer has led the two companies into forming a partnership aimed at placing a complete and integrated solution onto the market that is able to satisfy the many needs of financial intermediaries, from the controls laid down by the law to calculation of the portfolio risk of individual investors.

To be more precise, the solution on offer is mainly composed of:

- "I.A.C." (Investor Adequacy Care). This is a software product developed by CAD IT and has already been installed in some important Italian banking groups. It allows credit institutions to make the adequacy checks required by the Consob law (art. 29 of the Consob Regulation no. 11522/98), the European guidelines (CESR) and the "IX iniziativa Patti Chiari" promoted by ABI.
- A data processing flow generated and maintained by a PROMETEIA platform that interfaces several information sources and creates the numerous quality controls necessary in order to feed "I.A.C. modulo VaR" and therefore to determine the portfolio and security risk level for every single client.
- "I.A.C. Modulo VaR". This is a calculation software/motor jointly developed by CAD IT and PROMETEIA to measure the degree of risk involved for each single security and portfolio of individual investors (Retail Risk Management).

The strategic agreement between PROMETEIA and CAD IT, which has put the joint sale of the complete solution into action since May, has already been accepted by an important Italian Banking group.
